Please see below our proposal for repairs to be made at the address noted above. This quote is good for 30 days from the date of the proposal. A deposit and signed copy of the proposal is required to schedule a renovation.

Renovations Include:

- 1. Drain pool secure area to enable work to begin on pool.
- 2. Remove and replace (2) surface skimmers (Strongly recommended as they have been problem areas in the past.)
- 3. Chip out and repair crack with structural staples and Dal Seal suppression cloth.
- 4. Cut and chip out around lights, returns, and secure all possible leak areas.
- 5. Remove and replace waterline tile on pool (Allowance for tile is \$6.00 / ft. Upgrade tile is available and charged at a cost difference only.)
 Includes: New "Depth Markers" and "NO Diving" in waterline tile. (Per Code).
- 6. Remove and install new non-skid 2"x 6" bullnose cap tile on steps in pool.
- 7. Acid wash pool interior, and coat with bonding agent for better adhesion and bond to new finish.
- 8. Replace main drains (Code Compliant), return fittings, and any necessary fittings for circulation.
- 9. Acid wash pool and apply bond coat adhesive to ensure material adherence to old finish.
- 10. Apply new high strength exposed pebble aggregate (Silver pearl) to pool.
- 11. Fill pool and add necessary chemicals to balance water and resume weekly maintenance.
- 12. All required permits will be applied for as per local municipal codes.

ADDITIONAL WORK TO BE COMPLETED OR ADDED TO CONTRACT:

- *We recommend a 6"x 6" waterline tile due to durability and ease of maintenance.
